*Structured Securities Base Prospectus*

*Pursuant to the Programme for the Issuance of Securities*

This Supplement (the "**Supplement**") to the Prospectus dated July 29, 2014 (the "**Prospectus**"), which comprises a base prospectus under Article 5.4 of Directive 2003/71/EC as amended (which includes the amendments made by Directive 2010/73/EU to the extent that such amendments have been implemented in a relevant Member State of the European Economic Area) (the "**Prospectus Directive**") for Royal Bank of Canada ("**RBC**" or the "**Issuer**"), constitutes a supplementary prospectus in respect of the base prospectus for RBC for purposes of Article 16 of the Prospectus Directive and is prepared in connection with the Programme for the Issuance of Securities established by Royal Bank of Canada.

The Issuer produced listing particulars dated July 29, 2014 ("**Listing Particulars**") for the purposes of listing on the Global Exchange Market of the Irish Stock Exchange. The Listing Particulars does not constitute a "prospectus" for the purposes of the Prospectus Directive. This Supplement constitutes "supplementary listing particulars" for the purpose of listing on the Global Exchange Market of the Irish Stock Exchange. This Supplement has also been approved by the Irish Stock Exchange for the purposes of listing on its Global Exchange Market.

Terms defined in the Prospectus have the same meaning when used in this Supplement. The Supplement is supplemental to, and shall be read in conjunction with, the Prospectus and any other supplements to the Prospectus issued by RBC.

RBC accepts responsibility for the information in this Supplement. To the best of the knowledge of RBC, having taken reasonable care to ensure that such is the case, the information contained in this Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information.

The purpose of this Supplement is:

- (i) to incorporate by reference in the Prospectus the Issuer's unaudited interim condensed consolidated statements (the "**Third Quarter 2014 Financial Statements**"), which have not been audited or reviewed by auditors pursuant to the International Standard on Review Engagements (UK and Ireland) 2410, together with Management's Discussion and Analysis (the "**Third Quarter 2014 MD&A**") for the three- and nine-month periods ended July 31, 2014 set out in the Issuer's Third Quarter 2014 Report to Shareholders (the "**Third Quarter 2014 Report to Shareholders**"). The remainder of the Third Quarter 2014 Report to Shareholders is either covered elsewhere in the Prospectus or is not relevant for investors.

- (ii) following the publication of the Third Quarter 2014 Report to Shareholders, to update the statement of no significant change of the Issuer;
- (iii) to disclose the change to the ratings outlook by Standard & Poor's Financial Services LLC ("**S&P USA**") on RBC to negative from stable which was published on August 8, 2014;
- (iv) to disclose ratings given to RBC's Basel III-compliant subordinated notes issued this year;
- (v) to disclose recent developments relating to senior management changes; and
- (vi) to amend and restate the Programme Summary to update the same with respect to such financial information incorporated by reference and include certain of the other matters noted above.

To the extent that there is any inconsistency between (a) any statement in this Supplement or any statement incorporated by reference into the Prospectus by this Supplement and (b) any other statement in, or incorporated by reference in, the Prospectus, the statements in (a) above will prevail.

Save as disclosed in this Supplement, no significant new factor, material mistake or inaccuracy relating to the information included in the Prospectus which is capable of affecting the assessment of Securities issued under the Programme has arisen or been noted, as the case may be, since the publication of the Prospectus dated July 29, 2014.

**This Supplement has been approved by the Central Bank of Ireland as Irish competent authority under the Prospectus Directive. The Central Bank only approves this Supplement as meeting the requirements imposed under Irish and EU law pursuant to the Prospectus Directive.**

In circumstances where Article 16(2) of the Prospectus Directive apply, investors who have agreed to purchase or subscribe for securities before this Supplement is published have the right, exercisable before the end of the period of two working days beginning with the working day after the date on which this Supplement was published, to withdraw their acceptances. This right to withdraw will expire by close of business on September 25, 2014.

## STATEMENT OF NO SIGNIFICANT CHANGE

Since July 31, 2014, the date of the most recently published financial statements of the Issuer, there has been no significant change in the financial or trading position of the Issuer and its subsidiaries taken as a whole.

## ISSUER RATINGS

On August 8, 2014 S&P USA announced that it has affirmed the long term and short-term issuer credit ratings on RBC and revised its outlook on RBC along with the other five largest Canadian banks to negative from stable. The outlook revision reflects the possible impact of a bail-in policy proposal from the Canadian federal government, which was released on August 1, 2014.

The Issuer's Subordinated Notes Series 16, due July 17, 2024, which were issued in July 2014, are the Issuer's Basel III-compliant subordinated notes and have different credit ratings from the Subordinated Note ratings currently included in the Prospectus and Listing Particulars. The Subordinated Notes Series 16, due July 17, 2024, are rated "A-" by S&P USA and "Baa1 (hyb)" by Moody's USA.

### **RECENT DEVELOPMENTS**

On August 1, 2014, David I. McKay assumed his role as President and Chief Executive Officer of RBC, replacing Gordon M. Nixon, and was appointed to the Board of Directors of RBC.
